In other words, a "defendant is not entitled to an instruction on selfdefense where the sole issue is whether the defendant acted in self-defense, but where the defendant's sole defense is a claim that someone else did the killing, then the defendant may plead self-defense." (Emphasis supplied). Id. at 590. The Sanders opinion carefully distinguishes between the cases that deal with a defendant's claim that he was not present at the scene of a crime and a claim that he was not there at the time of the crime. Id. at 590-91. The supreme court explained: In these cases, there is a threshold determination that the criminal conduct committed by another person must have been reasonably sufficient to warrant the self-defense claim. In each of these cases, the defendant claims self-defense in those cases is he was not the perpetrator. There is a distinction between being a victim and being the perpetrator; and that distinction is what gave rise to the Sanders rationale.... The Sanders rationale had its genesis in a number of cases dealing with victims of crimes, asserting self-defense. In those cases, the defendant was someone other than the victim, but a person who allegedly committed the offense, alleging that the alleged perpetrator was the one who actually committed the crime. And the focus was on one issue: self-defense, namely, the issue of who did the killing. Where the defendant is asserting the killing was not committed by him,
